### A Bright Spot has Arisen on the Goatpacker's Horizon!

For the first time since this nonsensical attempt to throw our goats out of the woods first arose in 2011, there seems to be some good news. Please read through and see how you can actually have a hand in, if not stopping this juggernaut, at least slowing it down to a reasonable crawl!

Dr. Maggie Highland, a wildlife expert who has chosen not to blindly follow the standard wildlife biologist's mantra, 'goats are dangerous', 'goats are dangerous', is actually attempting to bring some sanity into this discussion.

What she has proposed, is a sampling of our animals to determine what percentage are carrying the most recent bad-guy pathogen in this arena, Mycoplasma ovipneumoniae (movi). Movi has emerged due to the recent research by Dr. Tom Besser, as a key player in the sickening of Bighorn Sheep.

What will be necessary is the nasal swabbing, and blood specimen drawing by a vet, with the samples being send to ADRU in Pullman, WA.

**Please note:** All costs will be covered by ADRU-ARS-USDA to perform this prevalence/surveillance project, including veterinary charges (when/ if applicable), supplies and shipping, and testing. However, this <u>is only in the event that we receive</u> <u>enough owners willing to participate in order to make</u> <u>this a statistically valid surveillance analysis</u>.

As noted above, the number of participants in this survey must be sufficient to make this a '*statistically valid surveillance analysis*'.

What we need from you right now, is an indication of your willingness to participate in this program. You can do that by returning to me your Name and eMail as before Maggie can begin this project, she/we need a valid estimate of the number of folks willing to participate.

Your participation in this program has the potential to drastically alter the current climate of hostility towards our goats. Please consider taking part. All it will ask of you is your time.
